Auction Notice (2nd Call)

Superintending Engineer, Birbhum District, Bhadrakali Sankar Sthapane Samiti of Murarai-II Panchayat Samiti dated on 11.07.2025 on work of "Aardh Samiti, Udayan-O-Panchayatana, Sthapane Samiti dated 12.06.2025 and permission issued by Forest Range Officer, Rampurhat Range vide Permit No. 13/RP of 25-26 Dated 10.07.2025, sealed bids are hereby invited from bonafide and reputed individual/agencies possessing for sale of tree logs of 36 Nos. of Eucalyptus tree through public auction on "As is where is basis" as per the attached list with the following terms and conditions mentioned below.

The following conditions should apply in sealed envelope in Annexure-1 and bidder should submit with self-attested following documents:

- (i) PAN Card
 - (ii) Aadhaar Card
 - (iii) Voter Identity Card
 - (iv) Up to date P. Tax
 - (v) Trade License
 - (vi) Experience in this nature of work having minimum 10% of base value from any reputed agency/company/firm
2. The intending agencies/individuals should drop the sealed envelope in the auction box kept at chamber of undersigned on any working days between 14.07.2025 to 22.07.2025 from 11.00 A.M. to 5.30 P.M. The last date and time for submission of quotation is 22.07.2025 at 5.30 P.M. The auction box will be opened on 23.07.2025 at 12.00 noon. Intending agencies/individuals may remain present at the time of opening of auction.
3. The intending bidders may inspect the tree logs on the date of auction i.e. on 23.07.2025 between 10.00 A.M. to 11.00 A.M. in presence of Secretary, Murarai-II Panchayat Samiti and Executive Officer, Murarai-II Panchayat Samiti. Any dispute made afterward regarding quality and quantity of the tree logs will not be entertained. No auction material will be shown before the date of auction. At the time of inspection, the intending bidders must produce the receipt of earnest money deposited by him/her.
4. The H₁ & H₂ bidder have to deposit an amount of Rs. 10,000/- (Rupees Ten Thousand) only as earnest money through cash immediately after completion of auction on 23.07.2025. However, the H₁ bidder should not be rejected till the EOI Process is successful.
5. The successful bidder has to deposit the quoted amount on before 24.07.2025 by 4.00 P.M. through Bank draft only drawn in favour of Executive Officer, Murarai-II Panchayat Samiti. If the H₁ bidder fails to deposit the draft within stipulated time period, H₂ bidder will be considered.
6. The successful bidder have to deposit an additional amount of Rs. 4,500/- (Rupees Four thousand five Hundred) plus the cash for the cost of labour and felling of trees.

- During the scrutiny, if it comes to the notice to the auctioneer involving that the credential(s) and/or any other papers of any bidder is/are incorrect/mala fide fabricated, that bidder will not be allowed to participate in the auction process and that application will be rejected outright.
8. Before issuance of the LOI, the concerned authority may verify the credential(s) and/or other document(s) of highest bidder, if found necessary. After verification, if it is found that the document(s) submitted by the highest bidder is/are mala fide false, the LOI will not be issued in favour of the said bidder.
 9. The successful bidder on receipt of the necessary lifting order shall remove the auctioned materials from the site in consultation with the concerned authority as per Govt. norms.
 10. If any damage or loss occur in Govt. property during sell of the auctioned materials, the concerned bidder will be responsible to compensate at his/her own cost.
 11. The concerned authority reserves the right to cancel any or all the offer without assigning any reason therefor.
 12. In case of any dispute, the decision of the Executive Officer, Murarai-II Panchayat Samiti will be final.
 13. Cost of removal will be borne by the bidder/bidders.
 14. During removal of tree logs all precautionary measures towards damage of Electric Line, Telephone Line or any structure should be made by the successful bidder properly. If any damage unexpected accident occur, compensation for such shall have to made by the successful bidder including safety of pedestrians.
 15. Before carrying auctioned materials NOC should be taken from the office of Murarai-II Panchayat Samiti as per existing Govt. norms.
